I. Elected Officials & Department Head Updates

To receive, as informational, departmental updates requiring Commissioner review, participation, approval, and impactful departmental and operational issues.

1: HR Director May said Chris and her met with Visa Solutions (VS) as May has been dissatisfied with the process. There had been some internal issues with VS and they apologized for their lack of communication.

May said policy changes are making it difficult for Canadian nurses to make it to the U.S.

May and Coates have reached out to our federal delegation for support in this process.

May said they have scheduled a monthly meeting with VS.

Right now, there is a TN candidate who is interested in a two-year contract versus a three-year contract. VS usually has three-year contracts, but May said she didn't mind the two-year plan.

Coates said the difficulty with nurses needing to get social security cards is at the federal level, the Board of Nursing problems are at the state level.

2: CCEMS Chief Kreamer said CCEMS responded to the mass casualty incident on Route 9 over the past weekend.

The Deputy Chief of Keene Fire reached out to Kreamer to thank him and his crew for their support.

Kreamer said there has been an uptick of serious calls for CCEMS. He said all of the crews are doing well and pulling together through this.

Commissioner DiBernardo asked about what happened with Ambulance A-5.

Kreamer said A-5 lost power in Hooksett. They got the vehicle towed to Ford. They could not diagnose the issue and brought it back to HQ. Last night, August 19, the vehicle lost power again.

Kreamer said a lot of repairs of the ambulances have been covered by warranty. The "intercooler" is not part of the warranty so that is a cost to the County. Kreamer said the warranty through Ford has been very problematic because they have to talk to corporate before approving anything, this can take days, and Ford does not start repairs until they hear back from corporate first. Kreamer said the repairs need to be done no matter what so he would prefer if they could begin repairs at once regardless of the warranty.
