Master Agenda Item #1325: Request for Rollover – S. Trombly

**Action Expected: To have the Commissioners authorize a rollover of funds for weatherization projects.**

1. Finance Director Trombly requested a \$20,000 rollover of funds for the weatherization project, as some projects were delayed and not finalized by year-end. She explained that this approval is needed for auditors.

**Commissioner Clark made a motion to approve the \$20,000 rollover of funds for weatherization projects. Commissioner DiBernardo seconded. Upon a roll call vote the motion passed unanimously.**

### **County Administrator**

Weekly Operations Report - The County Administrator will update the Commissioners on activities that have taken place since the previous meeting.

1. County Administrator Coates said he and Commissioner Clark attended a Martin Luther King Breakfast run by the City of Keene.
2. Coates said Finance Director Trombly and himself will be going to the State House to testify against House Bill 1427, which limits the authority of municipalities, counties, and school districts to issue bonds.
3. Coates said the budget review meeting on Monday January 26 could be delayed due to the weather forecast.

**III. Old Business**

1. Finance Director Trombly said that the Hinsdale tax bill arrived. Due to the lateness, the bill for Hinsdale included \$6,000-7,000 in interest.
2. The group addressed a significant issue regarding the potential loss of a \$4 million SAMHSA grant, which was reversed after advocacy efforts nationwide including from Cheshire County which involved meetings with congressional representatives and media coverage.
