At 9:30AM The Chairman opened the meeting and took-up Master Agenda Item #646: Senscio Presentation - A Home-Based Chronic Care System Optimized by Artificial Intelligence.

Mike Charley provided a background introduction of the programs that are currently in service and he spoke to PowerPoint slide deck. (See excerpts below)

Master Agenda Item #647: 2019 Audit Engagement Letter was then taken-up for discussion and Trombly presented the engagement letter for the Commissioners to review and sign. Following a short discussion, the letter was signed and returned to Trombly.

Master Agenda Item #648: Grants Policy Update was then discussed. Bansley presented her request to update the grants policy to incorporate language that she feels in missing in the current document. One of the items that drew the Commissioner attention was a change to the process of having the Commissioners not accept grants for the County but the grants could still be accepted by some elected officials for their departments. A discussion of what the NH State Statues allow and require began and it was determined that a better understanding of the law was needed before implementing the requested change is approved.

The staff will research the issue and the topic will be discussed at next week's meeting.

Administrator Coates recognized and presented the Weekly Operations Report

- A letter that was presented to the Fitzwilliam Select Board during a meeting on Monday night was
  reviewed and Coates discussed the meeting in detail. The towns tax payments and economic
  development were discussed with the Board. He said that it is important that the Commissioners and
  Senior Staff stay in communication with the town select boards and offer assistance and information
  especially immediately after elections.
- He reminded the Commissioners that next Monday at 9:00am the Executive Committee will review the Outside Agencies request for the 2019 budget.
- A date for Senator Sheehan to announce the addition of Cheshire County to the Northern Borders Regional Commission is expected to occur on or about February 21<sup>st</sup> or 22<sup>nd</sup>.
- Coates met with the Keene Career Center's Director and discussed a number of programs and
  initiatives including reestablishing the clinical portion of the LNA program at the Maplewood Nursing
  Home and a possible solution to the transportation problem to and from Keene High School. He said
  the lack of transportation prevented some participants in the LNA training program from being able to
  attend the clinical's at Maplewood.
- A meeting with the Executive Director of Mutual Aid was recently held and a contact list for all local Fire Departments and Ambulance personnel will be sent to Coates. He said the list will be used to establish meetings with them to begin dialogue on the idea of joint local service points to serve the needs of the two to three towns from the same facility.
- Attorney Bonsignore will present at next week's Commissioners meeting on the status of the statewide Opiate lawsuit.
- Coates reminded the Commissioners that the Integrated Delivery Network (IDN) meeting will be held at the Common Man in Claremont tomorrow.
- Coates then said that the monthly Association of Counties meeting will be held in Concord on Friday and that he and Trombly will attend.
