Commissioner Wozmak seconded the motion, and upon roll-call vote, the motion passed unanimously.

Emergency Order #12 Pursuant to Executive Order 2020-04 Temporary modification of public access to meetings under RSA 91-A Pursuant to Section 18 of Executive Order 2020-04, it is hereby ordered, effective immediately, that:

1. Pursuant to Executive Order 2020-04, paragraph 8 provides: "State and local government bodies are permitted and encouraged to utilize the emergency meeting provisions of RSA 91-A to conduct meetings through electronic means while preserving, to the extent feasible, the public's right to notice of such meetings and ability to observe and listen contemporaneously."

The program, now called Community Power Coalition of NH, allows towns, cities, and County's to buy and resell electricity for their constituents, often at lower rates than the current default rates from the large utilities, and to supply green and clean electricity options.

The Commissioners then took-up Master Agenda Item #832: CDBG Hearing - Renovation of 105 Castle Street - \$500,000 for discussion.

At 8:35 AM, Commissioner Weed opened the First Public Hearing: Community Development Block Grant Application

Commissioner Weed stated the following; The Cheshire County Commissioners will hold two consecutive public hearings on Wednesday, December 16, 2020, at 8:30 a.m. Pursuant to Emergency Order #12, issued by the Governor of the State of New Hampshire pursuant to Executive Order 2020-04, the public hearings will be conducted electronically via the web-based platform Zoom. Members of the public can use the Zoom call-in number at +1 (646) 558-8656 or by joining online at www.zoom.us/join and using the Meeting ID: 409 748 8803 and Pin: 6031233 to participate.

The purpose of the first public hearing is to discuss an application to the NH Community Development Finance Authority for federal Community Development Block Grant (CDBG) funds. CDBG funds are awarded on a competitive basis in New Hampshire and may be used for projects in a wide variety of categories that have a primary benefit to low- and moderate-income individuals. A municipality can apply for up to \$500,000 in CDBG funds per year in each of the following project categories: housing, public facilities, economic development, and microenterprise technical assistance. Municipalities can also apply for up to \$500,000 in emergency funds and \$25,000 for feasibility studies annually.

The proposal to be considered by the Commissioners is a CDBG application to be submitted by Cheshire County on behalf of Keene Housing for \$500,000. The funds, less administrative costs, will be subgranted to the Monadnock Affordable Housing Corporation (MAHC), a 501c3 nonprofit affiliate of Keene Housing. In combination with other sources, the funds will be used for the renovation of 105 Castle Street, which is located in the Harper Acres housing development. The Monadnock Collaborative now occupies the building and serves as a community space for Harper Acres residents. This public hearing has been scheduled to provide specific information regarding the proposal and grant requirements. A second public hearing will be held to adopt the Relocation and Anti-Displacement Plan specific to this project.

Weed then recognized James Weatherly to address the grant request who stated the following.

My name is James Weatherly, and I am the CDBG Grant Administrator with the Southwest Region Planning Commission. I will start by providing a brief overview of the federal Community Development Block Grant (CDBG) program, and then I will tell you about this particular application.

CDBG funds are available to municipalities for projects that primarily benefit low- and moderate-income persons. Cheshire County is eligible to receive up to \$500,000 a year for each of the following categories: public facility improvements, housing projects, economic development, and emergency funds. Feasibility study funds are available for up to \$25,000. I have provided a handout describing the NH Community Development Block Grant Program eligible activities that include the area HUD income limits.

The proposed application to the New Hampshire Community Development Finance Authority (CDFA) is for up to \$500,000. The CDBG funds will be used to rehabilitate 105 Castle Street by the Monadnock Affordable Housing Corporation, a nonprofit affiliate of Keene Housing. 105 Castle Street is home to a variety of uses, including serving as the home of Monadnock Collaborative, ServiceLink, Choices for Independence, and serving as a distribution point for the Meals on Wheels program administered by Home Health Care. The facility also provides a community space and laundry facilities for Harper Acres residents, a Keene Housing development that provides housing to low-income seniors and disabled persons. Rehabilitation of the facility will address accessibility, energy efficiency, and capital improvements and specific retrofits aimed at improving the delivery of public services.

The exact percentage of low- and moderate-income benefit is being determined; however, all of Harper Acre's residents are low- to moderate-income. I have provided a handout describing the project. The project conforms to Cheshire County's Housing and Community Development Plan, last passed in January of 2019, specifically the goal to "Support existing... nonprofit agencies that provide services to lower-income people".

I am also here today with Josh Meehan and Maryann Ferguson from Keene Housing who will provide additional project details.

The Chair then recognized Josh Meehan to address the grant request. Meehan described the project at Castle Street and said several building issues, including roofing, structural, and HVAC, all need rehabilitation. They have been working with architects, and it is anticipated that the project will cost about \$1.8M. The rest of the monies will come from Eversource and Monadnock Collaborative, with construction to begin in 2021 and conclude in 2022. Maryann Ferguson of Monadnock Collaborative then spoke and highlighted the work being done for veterans and low-income individuals. She outlined several other community support programs and said a very close relationship with the County exists on many programs. She discussed the reason for maintaining their presence in Keene and noted that the renovation would enable them to stay at their present location for the next twenty years.

The Chair then opened the floor to public comments and questions about the proposed CDBG project. **No public comments were received.**

The Chair then opened the floor to staff and commissioners for comment. Commissioner Englund asked which building on Castle was being renovated. He also asked about the definition of low to moderate-income. Weatherly answered both questions to the Commissioners satisfaction.

The Chair moved to close the public hearing for the proposed Community Development Block Grant application and asked for a motion on the CDBG grant application.

Commissioner Wozmak moved to approve the submittal of the application and vote to authorize County Administrator Chris Coates and the County Commissioner Chair as the Authorized Designees to sign and submit the CDBG application, and upon approval of the CDBG application, authorize the Authorized Designees to execute any documents which may be necessary to effectuate the CDBG contract. Commissioner Englund seconded the motion. Upon roll call vote, the motion passed unanimously.

The Second Public Hearing on Residential Anti-displacement and Relocation Assistance was then taken-up by the Chair, and he opened the second public hearing for discussion and recognized James Weatherly to address the Residential Anti-displacement and Relocation Assistance Plan.

Weatherly then said that if any displacement occurs as a result of the proposed CDBG project, the Uniform Relocation Act must be followed. The Act requires that displaced households or businesses in a project using federal funds must be found comparable housing or commercial space in a comparable neighborhood at a comparable price. Under the certification section of the application, the County will certify that the Residential Anti-Displacement and Relocation

Assistance (RARA) Plan is in place, and in the event that it is discovered that this specific project does displace persons or households, a displacement implementation plan must be submitted to CDFA prior to obligating or expending funds. At this time, displacement is not anticipated for the proposed project as 105 Castle Street is not a residential property.

The Chair then opened the floor to public comments and questions about the Residential Antidisplacement and Relocation Assistance Plan, and **no comments were received**.

The Chair then opened the floor to staff and commissioners for comments, and **no comments** were received.

The Chair then closed the public hearing for the Anti-displacement and Relocation Assistance Plan public hearing and asked for a motion to adopt the Residential Anti-displacement and Relocation Assistance Plan.

Commissioner Wozmak moved to adopt the Anti-displacement and Relocation Assistance Plan plan and was seconded by Commissioner Englund. Upon roll call vote, the motion passed unanimously.

The documents necessary for the submittal of the CDBG application were provided for signing.

Master Agenda Item #832: Clean Power Coalition of NH - was then taken-up for discussion and to receive an informational briefing from Henry Herndon on the Clean Power Coalition of NH and vote to adopt program membership and Cheshire County participation.





An extended discussion then began about the advantages for the County to be involved with Clean Energy NH and the newly forming municipal and County organization to be known as Community Power Coalition of NH (CPCNH).

Herndon said that the purpose of CPCNH is for local governments, cities, towns, and counties to procure and provide electricity and services for their residents and businesses.

He said that CPCNH is in final stages of formalizing its legal foundational documents and its initial membership will include the cities of Nashua and Lebanon, the town of Hanover, and Cheshire County as well as up to thirty-one other towns and cities across the state.

Herndon then discussed the advantages to joining CPCNH saying that local control, lower costs, the use of renewable energy sources, and energy resilience were all reasons that many communities are interested in joining together to purchase energy for their communities.

A number of other advantages including the use of RSA 53-E to enable local power generation was covered in detail.

The Commissioners thanked Herndon for his presentation and said that the program sounds very interesting and needed. Coates and Bouchard will bring recommendations to the Commissioners for consideration in the next few weeks.

The Commissioners then addressed Master Agenda Item #834: 2020 to 2021 Budget Rollovers. Trombly was recognized and discussed the rollovers from 2020 to 2021.

She reviewed the list which is larger than normal for year-end roll overs due to the budgety freeze on capital expenditures instituted by the Commissioners at the beginning of the panademic until the tax revenues from the towns could be accurately assessed in December.

She said that she was informed that Stoddard just sent out their tax bills last week and will not be able to make the full tax payment to the County until they receive there remissions. She said that as of today, she believes that the other towns have submitted or plan to submit their full payments. A discussion of how town tax bills are handled began and it was discussed that some of the tax payments will probably not be received until late January.

Following discussion Commissioner Wozmak moved to encumber the rollover list from the 2020 to the 2021 budget and was seconded by Commissioner Englund. Upon roll call vote the motion passed unanimously.

Commissioner Wozmak then moved to lift the freeze on Capital expenditures once eightypercent (80%) of all tax revenues have been collected from the towns. Commissioner Englund seconded the motion and upon roll call vote the motion passed unanimously.

Rob Diluzio states, "Respiratory compromise is one of the most common and critical symptoms of COVID-19. With these ventilators, not only will we be able to provide advanced ventilator support for patients in the pre-hospital environment, we will also be able to more efficiently and effectively transport critically ill patients between our local hospital and other specialized tertiary care facilities".

The ventilators give Diluzio the ability to provide better respiratory care with exact settings for each patient. Not only will these units provide ventilator support to COVID patients, but they will also be used to treat other patient populations such as those with other respiratory compromising conditions.

Diluzio goes on to state, "The addition of the IV Infusion Pumps will allow us to better manage some of the most critically ill COVID-19 and septic patients. To treat severe sepsis in the out of hospital environment, we can administer IV fluids and vasoactive pharmacological agents. These interventions are most appropriate and sometimes required to be administered via an IV Infusion Pump to better control and manage the doses and volumes given. Other medications and treatment modalities can also be provided via these pumps".

The Commissioners then returned to a discussion of the letter sent to the Delegation and the importance of everyone wearing a mask while on County campuses. The untimely death of the new Speaker of the NH House due to COVID-19 was covered, and the rise of the COVID infection rate at the state offices was discussed.

B. based on increased duties and responsibilities in their new position. Commissioner Englund seconded the motion and upon roll call vote the motion passed unanimously.**
