Bansley was recognized and explained the purpose and request of the grant to help fund the upgrade of the Sheriff's department public safety radio network. Bansley said in response to a question about the rating and ranking of the applications that are under review that she believes the application has a good chance of being awarded. A discussion of how the grants are awarded and administered began. At the conclusion of discussions, Commissioner Wozmak moved to sign an authorization for County Grants Manager to submit an application to the NBRC State Economic & Infrastructure Development Investment Program for an \$875,000 grant with a \$1,624,532 match to upgrade Cheshire County Dispatch telecommunications infrastructure; and vote to authorize County Administrator Coates or County Commissioner Chair Wozmak to accept funds and enter agreements if awarded. Commissioner Clark seconded the motion, and upon roll call vote, the motion passed unanimously.

Drew provided a comprehensive overview of the program, and she said that she was awarded a grant in March of this year that runs for one year and is focused on employer staff addiction issues. She said that the focus for Reality Check in the coming year would be working with employers.

She said that Reality Check provides training for Recovery Coaches and Master Licensed Alcohol and Drug Counselors (MLADC) for certification and license awards. She noted that funding sustainability is the biggest problem that they face. They have continued to provide services in some areas even when funding has ended in some cases to assist employers and individuals.

The certification process for healthcare professionals was discussed, and it was reiterated that the State is a barrier to the certification of healthcare licensure. It was stated that another significant issue is that the low or no compensation available for Recovery Coaches prevents people interested in working in the field from participating.

The cost of services was covered, and how many small employers cannot pay for the services for their staff and therefore are at constant risk of losing trained staff due to addiction-related issues.

The treatment options for those with addictions were discussed, and it was related that there is only very few medium to long-term resident options for NH residents. Drew said that a Substance Abuse and Mental Health Services Administration (SAMSHA) grant Building Communities of Recovery grant is being sought this year to help fund the operation.

The discussion of Medicated Assisted Treatment (MAT) began. It was related that despite using suboxone to help end addiction, there is often no actual personal treatment offered through counseling due to a lack of qualified recovery coaches and professional counselors.

The Commissioner thanked Drew and Beeler for their presentation and then took-up Master Agenda Item #990: Semi-Annual Report – UNH Cooperative Extension Action Expected: To receive as informational a report from the Cheshire County Cooperative Office Manager a report on the operations of the Extension Office.

Majewski was recognized and provided an update and the following information.

Lastly, Coates said that he would meet with a local owner of an apartment building to determine if it could be used for traveling nurses' housing at acceptable rates and terms.
